## REQUIREMENTS AND QUALIFICATIONS

To ensure a high-impact learning experience, the ECMA Summer Camp 2025 seeks motivated university students and young professionals who meet the following criteria:

#### **For University Students:**

Must be a 3rd or 4th-year undergraduate in fields such as Accounting & Finance, Economics, Business Administration, Law, IT/Computer Science, Statistics, Journalism & Communication, or related disciplines.

#### For Young Professionals:

Recent graduate not more than 2 years since graduation

#### The applicant must have a CGPA of 3.5 and above for both criteria.
